- e. In case construction / development work is carried out before the approval of the Plan, the violations of the concerned bye-laws, if any, shall be removed.
- f. Mandatory spaces shall not be violated.
- g. In case the site is acquired by any Government agency for development activity in public interest, I shall have no objection.
- h. The site shall only be used for the given purpose / use, any future change in approved purpose / use shall require fresh sanction from the concerned TMA / Authority.
- i. If at any stage it is proved that documents, information and plans provided by me / us were incorrect or forged or bogus, City District Government Gujranwala shall have the right to modify, suspend, cease, withdraw or cancel the permission, at any time.
- j. Any oversight in the scrutiny of the application, documents etc. does not vests to me / us any right of violation of the Rules, Government instructions on the subject.
- k. If at any later stage, it is pointed out by any competent authority or it is found that the requisite fees have been deposited less than the actual / demanded, I / we shall be bound to pay the balance amount.
- l. The deposition of fee does not confirm, authenticate, entitle me / us the ownership of the property and is only for the construction of the building.
